CONDITIONS OF ISSUE AND USE

1. You are only entitled to a Transport Concession Card if you are a 1st, 2nd, or 3rd year apprentice/trainee apprentice or a new entrant trainee employed under the *NSW Apprenticeship and Traineeship Act, 2001* and have been issued with a TCID number by the NSW Department of Education and Communities (DEC).
2. Applicants must complete this form (VT77) neatly and accurately, have it certified by their employer and attach a colour passport size photo (with the applicant's name and employer's signature on the back). **Note:** Incomplete applications will be returned.
3. A concession card that is lost, damaged, stolen or confiscated may be replaced on submission of completed application form (new photo not required) and payment of the prescribed replacement fee, to the Passes and Concessions office.
4. The inclusion of incorrect or misleading information in an application by either the applicant or employer will expose both parties to the risk of prosecution.
5. The concession card is **NOT TRANSFERABLE** and must be shown when purchasing tickets and when requested by a Transport Officer. The concession card will not be accepted if it contains any alterations, erasures or additions, or if it is damaged.
6. Card holders **MUST** abide by the Conditions of Issue and Use. Failure to do so may result in the confiscation/cancellation of the concession card, prosecution and/or forfeiture of future transport concession entitlements.
7. The concession card gives entitlement to concession travel on all regular route local bus services across NSW **AND** for concession travel between the holders home, workplace and college/RTO on Sydney Trains and NSW trains intercity services and Sydney and Newcastle Ferries services. The concession card is not available for use on NSW Trains rural or regional services or the following bus services – special, premium, charter, tourism and some private services.
8. Holders are entitled to purchase concession single or return tickets, MyTrain tickets, MYMulti Day and Weekly tickets **ONLY** and TravelTen tickets.
