#### Evidence of residency

If you submit your application form in person, you are required to bring document/s that prove that you are an Australian Citizen or the holder of a permanent visa.

This evidence must be a certified true copy of the original documentation and must include the certifier's name, title and registration number (where applicable), their original signature and the date. The certifier must state the following 'I certify that I have sighted the original document and that this is a true copy of it'.
